

RSC special Issue European Union Grand Strategies – prospects of Europe 2030

Call for Contributions

The subjects of the upcoming special issue in Research in Social Change (RSC) are the processes that occur wile grand developmental strategies (like **EU grand strategies**) are formed and implemented. The European Union implementation deficit has become proverbial and the Lisbon Strategy itself is widely perceived as a failure, a phenomenon being the subject of intense interest by both researchers and policy-makers (Makarovič et al 2014; Haverland and Romeijn 2007; Borghetto and Franchino 2010; Tomšič and Vehovar 2012). While the impact of Europe 2020 is yet to be researched in greater detail, some work already exists (Stec and Grzebyk, 2018; Makarovič et al, 2014). Thus, a great effort was made into the development of cybersecurity and data protection, artificial intelligence and supercomputers, strengthening of democracy, strengthening the economy, creating a climate-neutral Europe fit for digital age and many more. Nevertheless, the prospects for the **Europe 2030** remain open for research and discussions as well.

Engaging in discussions on the topic of social change, the special issue of RSC aims to better understand different phenomena at the level of the EU through varied perspectives where academia, policy-makers, industry and civil society co-create the future and drive structural changes. The issue pursues contribution of interdisciplinary, pooling expertise on European Union scientific papers from sociology, political science, economics, law, regional studies and other related fields.

RSC is an interdisciplinary journal aiming to engage a wider academic audience by questioning and exploring the nature and impacts of changes in social institutions, changes in social behaviour and changes in social relations as they occur on a daily basis. RSC publishes original research articles with a clear contribution to the social sciences and here discussed through empirical or theoretical argumentations while the editors especially encourage new methodological approaches as well as innovative theoretical considerations. RSC welcomes but is not limited to, the contributions of young and prospective academics both at the start or on the advancement of their careers.

Submitting your work

- The editors accept original contributions in English language. By submission of a manuscript an author certifies that the work is original and is not being considered simultaneously by another publisher.
- Manuscripts should normally be between 6000-8000 words. All manuscripts will be peer reviewed and only those receiving favourable recommendation will be accepted for publication.
- Manuscripts should be written in British English.

- Authors are supposed to follow the <u>instructions</u> that are available on journal website.
